## **10 Years of the Turin Centre on Emerging Economies: lessons learned and perspectives for the future**

The 10th OEET Workshop will be held on **November 28-29, 2024** in Turin.

OEET invites abstract submissions for paper presentation on the main topics of the Workshop. The focus of the 10<sup>th</sup> Workshop will be on a retrospective analysis of the past 10 years and on future perspectives regarding emerging economies.

The workshop will be structured in three sessions according to the main research areas of OEET:

- 1) Economic development, growth and inequality in emerging economies
- 2) Emerging economies in Global Value Chains
- 3) Sustainable development and the Agenda2030 in emerging economies.

The first session mainly focuses on the growth-inequality nexus, paying special attention to its evolution over the last decades, the non-linear relationship between these two dimensions and the policy debate about inclusive growth. The second session addresses how the recent geopolitical tensions and climate goals have impacted cross-border relations and the organization of Global Value Chains (GVCs), with a view to understanding how the resulting increased political pressure for “near shoring” and resilience in advanced economies is likely to impact on emerging economies worldwide. The impact of artificial intelligence on GVCs will also be analyzed. Finally, the third session covers the factors of success and failure in the achievements of the Agenda2030 in emerging economies since its launch and discusses how to get it back on track as well as the challenge of sustainable development in the post-2030 era.

Sessions will be supervised by coordinators, who will introduce the topic by highlighting the main trends observed during the last decade and lead a well-focused discussion about the future challenges. Both theoretical and empirical contributions are welcomed on, but not limited to, the issues listed below for each session:

### **1) Economic development, growth and inequality in emerging economies**

Coordinator: Maurizio Bussolo, World Bank

- Long-term evolution of inequality within and between countries
- Inequality of opportunity
- Inclusive growth and redistribution policies

### **2) Emerging economies in Global Value Chains**

Coordinators: Alessia Amighini, University of Eastern Piedmont, and Giorgia Giovannetti, University of Florence

- Emerging economies in international trade and investment networks
- Sectoral economic networks involving emerging economies
- Case studies of emerging economies in specific GVCs

### **3) Sustainable development and the Agenda2030 in emerging economies**

Coordinator: Donatella Saccone, University of Pollenzo

- Progress and failure in SDG achievements
- International spillovers, trade-offs and synergies in sustainable development
- Financing sustainable development and the green transition
